Storm Water Pump Station (Scope D)

BES personnel have monitored as described in approved Scope D and continue recording canal levels on both the intake and discharge side of the pump station as well as pump/gate operation and elapsed time readings. BES has performed weekly functional and load testing for gates, pumps and the emergency generator and is monitoring system telemetry for operational status changes.

The station performed as designed throughout December 2021.

RE: ENGINEER'S REPORT FOR DECEMBER 2021

The following is a summary of activities and communications that were of significance during the past month:

A. Fire Protection System Improvements - Phase 2

AECOM was informed by Clark Cryer from Johnson-Davis that they would be sending a crew out after the holidays to complete the punchlist items and that he would follow-up on the asbuilts and get back to us. AECOM has not received confirmation from J-D that the punchlist work has been completed, nor have the asbuilts been received. AECOM received an email from Rich Heller regarding the one section of old fire main that they have not been able to locate to cut and cap, and then grout the line. AECOM has requested a quote from the utility locate company, fka Groundhound, to locate the pipe.
